भारतीय प्रौद्योगिकी संस्थान पटना अपने क्षेत्र के अंतर्गत उच्च स्तर के तकनीकी शिक्षा एवं शोध हेतु कटिबद्ध है और देश के आवश्यकतानुकूल तकनीकी विशेषज्ञ एवं वैज्ञानिक तैयार करने हेतु प्रतिबद्ध है। आई.आई.टी. पटना एम.एच.आर.डी. के आदेश सं. एफ नं. 11-10/2008/टी.एस.1 (पी.टी.) दिनांक 09 मई 2008 (अनुलग्नक- I देखें) के द्वारा अस्तित्व में आया। आई.आई.टी. पटना की परामर्शदाता की जिम्मेवारी आई.आई.टी. गुवाहाटी को दी गई थी। जिसका सहमति अधिशासी समिति द्वारा अनुलग्नक-II में दी गई। आई.आई.टी. गुवाहाटी के निदेशक एवं अध्यक्ष ही इस नवनिर्मित आई.आई.टी. पटना के निदेशक एवं अध्यक्ष एम.एच.आर.डी. के आदेश सं. एफ नं. 11-10/2008/टी.एस.1 दिनांक 21 जुलाई 2008 के द्वारा (अनुलग्नक-III देखें) बनाये गये। बिहार सरकार द्वारा संस्थान एवं छात्रावास हेतु नवीन राजकृत पोलिटेक्निक के परिसर में जगह दी गई। 24 जुलाई 2008 को आई. आई.टी. पटना संस्थान सोसाइटी के रूप में विधिवत पंजिकृत हुआ (अनुलग्नक-IV देखें)। आई.आई.टी. पटना के शिक्षासत्र का शुभारम्भ 06 अगस्त 2008 को आई.आई.टी. गुवाहाटी के शिक्षकों एवं कर्मचारियों ने स्वयं यहाँ रह कर प्रारम्भ किया। उस समय से कुल सचिव सहित कुल 26 विभागीय प्राध्यापक एवं 13 गैर शैक्षणिक कर्मचारी लिए गये हैं। 06 कर्मचारी की बहाली की अभी हाल में सम्पन्न हुई। प्रथम वर्ष एवं द्वितीय वर्ष के छात्रों हेतु प्रयोगशालाएं स्थापित हैं। पी-एच.डी. का प्रोग्राम जुलाई 2009 में प्रारम्भ हुआ।

आई०आई०टी० पटना का शुभारंभ

दिनांक 15.5.2008 को आई० आई० टी० गुवाहाटी के निदेशक प्रो० गौतम बरूआ एवं छात्र गतिविधि अधिष्ठाता प्रो० समरेन्द्र दंडपत ने पटना का दौरा किये। वे लोग बिहार सरकार के प्रधान सचिव, विज्ञान एवं तकनीक विभाग के सचिव, भवन सचिव एवं बिहार सरकार के अन्य अधिकारी से मुलाकात किये। वे लोग इस निर्णय पर पहुंचे कि तत्काल अस्थायी तौर पर इसका प्रारंभ नवीन सरकारी पोलिटेक्निक पाटलिपुत्र कॉलोनी, पटना सिटी के प्रांगण में किया जाये। बिहार सरकार द्वारा चार मंजिला भवन जिसमें 1000 वर्ग मीटर जगह प्रत्येक तल्ला पर मुहैया किया गया।

दिनांक 03.06.2008 को प्रोफेसर एस. दण्डपत (अधिष्ठाता, आई० आई० टी० पटना), प्रोफेसर ए० श्रीनिवासन (प्रशासन, आई० आई० टी० गुवाहाटी), श्री एल० एन० शर्मा (वरिष्ठ साइंस ऑफिसर, आई० आई० टी० गुवाहाटी) एवं श्री धर्मेन्द्र सिंह (कनीय लेखालिपिक) सम्मिलित रूप से पटना आये। वे लोग कैनरा बैंक के पाटलिपुत्र स्थित शाखा में आई. आई. टी. पटना का एकाउन्ट खोले। नवीन पोलिटेक्निक पाटलिपुत्र कॉलोनी पटना के प्रांगण में आई० आई० टी० पटना का शुभारम्भ हुआ। तकरीबन 25 फलैट को किराये पर लिया गया और उसमें शिक्षक एवं कर्मचारियों को रखा गया। कुछ फलैट को गेस्ट हाउस बनाया गया।

छात्रावास

अस्थायी कम्प्लेक्स में सटे पोलिटेक्निक के दो छात्रावास को पुनर्निर्मित किया गया। प्रत्येक में 52 कमरे हैं। प्रत्येक कमरा में दो विद्यार्थियों को सामंजित किया गया है। प्रत्येक छात्रावास में कुल 104 छात्र सामंजित हुये। प्रत्येक तल्ले पर पृथक स्नानगार निर्मित किये गये (कुल तीन तल बने हैं), निचले तल्ले में एक डाइनिंग रूम तथा किचन के स्टाफ हेतु जगह है। छात्रावास के बाहर खुली जगह का इस्तेमाल खेल के मैदान के रूप में होता है। लड़कियों को चार फ्लैट में सामंजित किया गया है।

प्रयोगशाला

नवीन पोलिटेक्निक के रसायन प्रयोगशाला को पुनर्निर्मित कर इसका इस्तेमाल प्रथम वर्ष के रसायन प्रयोगशाला के रूप में किया गया है। बगल का शेड को कार्यशाला एवं यांत्रिक इंजिनियरिंग प्रयोगशाला हेतु रखा गया है। प्रथम वर्ष की उत्कृष्ट प्रशिक्षण प्रयोगशाला जैसे रसायन प्रयोगशाला, भौतिक प्रयोगशाला, गणना प्रयोगशाला, मूलभूत विद्युत विज्ञान प्रयोगशाला अभियांत्रिक कला एवं कार्यशाला इत्यादि प्रतिस्थापित है। एक कम्प्यूटर सेन्टर सर्वर एवं 4 एम.बी.पी.एस., बी.एस.एन.एल. इन्टरनेट कनेक्शन के साथ प्रतिस्थापित है। डोमेन नाम में iitp.ac.in और iitp.ernet.in. आई० आई०टी० पटना हेतु रजिस्टर्ड है। प्रत्येक विद्यार्थी को लैपटॉप दिया गया है। कार्यालय क्षेत्र एवं छात्रावास क्षेत्र में वाई-फाई प्रतिस्थापित किया गया है। इंजिनियरिंग ड्राइंग प्रयोगशाला के लिये कैड सॉफ्टवेयर है। प्रयोगशाला का फर्निचर पटना का ही डिजाइंड एवं अधिग्रहीत है। कार्यालय का फर्निचर गोदरेज का खरीदा गया है। प्रयोगशाला हेतु सभी जरूरी संसाधन स्थापित है। सेंट्रल लाइब्रेरी में जरूरी टैक्सट एवं रेफरेंस बुक उपलब्ध है। भिन्न-भिन्न तकनीकी एवं वैज्ञानिक जर्नल को ई-रिसोर्स (स्रोत) हेतु इनडेस्ट - ए.आई.सी.टी.ई. संसाधन उपलब्ध है।

प्रथम सेमेस्टर हेतू आठ विभागीय सदस्य आई०आई०टी० गुवाहाटी से लिये गये हैं, जिसमें दो रसायन दो भौतिकशास्त्र एक एम.ई. में एक ई.सी.ई. एवं दो गणित हेतू। प्रशासनिक कार्य संपादन हेतू तीन स्टाफ की प्रतिनियुक्ति की गयी है।

सत्र प्रारंभ होने से पूर्व छात्रावास एवं कार्यालय वाटर कूलर, वाटर फिल्टर, टी.वी, फैक्स मशीन, फोन आदि तथा कैंटीन, सुरक्षा एजेंसी, सफाई एवं बागवानी, इन्टरनेट संचालन हेतू लीज लाईन की व्यवस्था की गई।

छात्रावास में निर्वाध बिजली एवं पानी की सुविधा है। क्रीड़ा एवं मनोरंजन हेतु छात्रों को छात्रावास में टेबूल टेनिस, कैरम, टी.वी. रूम उपलब्ध है। छात्रों को स्वस्थ एवं चुस्त रहने हेतु छात्रावास के अन्दर ही व्यायामशाला उपलब्ध है। छात्रावास से मात्र तकरीबन 300 मीटर की दूरी पर छात्रावास के वार्डेन का क्वार्टर उपलब्ध है। संस्थान में आउटडोर सर्विस हेतु प्राइवेट चिकित्सालय द्वारा एक घंटा प्रतिदिन सप्ताह में कुल पांच दिन चिकित्सा संबंधित सेवा उपलब्ध है। दो प्राइवेट चिकित्सालय के क्रेडिट के आधार पर इन्डोर सर्विस का कॉन्ट्रैक्ट है। प्राइवेट चिकित्सालय तकरीबन छात्रावास से 2 किलोमीटर की दूरी पर अवस्थित है। इमरजेन्सी सेवा हेतु 24 घंटे एंबुलेंस की सुविधा उपलब्ध है। आई.आई.टी. पटना के छात्रों अतिरिक्त पाठ्यचर्चा एवं सह-पाठ्यचर्चा गतिविधि में शामिल रहे हैं। आई.आई.टी. पटना के प्रथम वार्षिक उत्सव 2009 के अवसर को वे लोग बखूबी आयोजित किये। इस अवसर पर छात्रों को खेल एवं अतिरिक्त कार्यक्रम में पुरस्कृत किया गया ।

Indian Institute of Technology Patna, had been conceived to bolster high quality technical education and research in the region and to cater to the nation's need for well groomed technocrats and scientists. IIT Patna came into existence by the MHRD Order No. F. No.11-10/2008/TS. I (Pt.), dated May 9, 2008 (see Annexure-I). IIT Guwahati was entrusted with the responsibility of mentoring IIT Patna. Its BoG approval is attached as Annexure-II. The Director and the Chairman of IIT Guwahati were appointed as Director and Chairman respectively of the new Institute, IIT Patna vide MHRD Order No. F. No. 11-10/2008 – TS.I, dated July 21, 2008 (see Annexure-III). IIT Patna has been registered under the Societies Registration Act (Annexure-IV). The Govt. of Bihar made available the space in the campus of the Navin Government Polytechnique in Patna city. This included the hostel space. Formally, IIT Patna was registered as a society on 24th July 2008. IIT Patna's academic programs commenced from 6th August 2008 with faculty and staff from IIT Guwahati staying at Patna and taking care of teaching and administration. Since then, 26 faculty and 13 non-teaching staff were put in place, including appointment of the Registrar. Selection of further 6 staff was completed. Laboratories for the first and second year classes were already in place. PhD programmes were to commence from July 2009.

Starting of IIT Patna

Director IIT Guwahati, Prof. Gautam Barua, and the Dean Students' Affairs, Prof. Samarendra Dandapat, visited Patna on 15/5/2008. They met the Chief Secretary, the Secretary Science and Technology, Secretary Buildings, and other officials of the Govt. of Bihar. It was decided to start IIT Patna from temporary premises in the campus of the Navin Govt Polytechnic, Pataliputra colony, Patna city. A new four story building with each floor area of 1000 sqm was allotted by Govt. of Bihar.

The team comprising of Prof. S. Dandapat, Dean (IITP), Prof. A. Srinivasan, Dean (Admn, IITG), Mr. L. N. Sharma (Sr. Sci. Officer, IITG), Mr. Dharmendra Singh (Jr.Accountant, IITG) arrived Patna on 03.06.2008. They opened the IIT Patna account in the Canara Bank, Patliputra Colony Branch. The office of IIT Patna was started at the premise of Navin Polytechnic, Patliputra Colony, Patna. About 25 flats were hired where faculty and staff were accommodated. Few flats were used as the guest house.

Hostels

Adjacent to the temporary complex, two hostels of the Polytechnic were renovated. Each had 52 rooms. Each room was used to accommodate two students. Each hostel could accommodate 104 students. More bathrooms were added on each floor (there are three floors). The ground floor had a dining room and space for kitchen staff to stay. The open space around the hostels was used as playground. The girls were accommodated in four flats.

Laboratories

The Chemistry laboratory of Navin Polytechnic was renovated to conduct the first year chemistry laboratory. An adjacent shed was renovated for Workshop and Mechanical Engineering laboratories. State-of-the-art teaching laboratories for first year classes such as Chemistry Laboratory, Physics Laboratory, Computing Laboratory, Basic Electrical Sciences Laboratory, Engineering Drawing and Workshop were set up. A computer centre with adequate number of servers and a 4 Mbps BSNL Internet connection was set up. Domain names, iitp.ac.in and iitp.ernet.in, for IIT Patna were registered. Each student was given a laptop. Wi-Fi was installed in the office area and in the hostel area. CAD software was procured for the Engineering Drawing laboratory. Laboratory furniture were designed and procured from Patna. Office furniture were purchased from Godrej. All the standard equipments required for the laboratories were procured. National Knowledge Network has equipped IIT Patna with a 1 Gbps internet connection for video conferencing.

A Central library with the required text and reference books was set up. On line access for e-resources under the INDEST-AICTE Consortium was subscribed for various technical and scientific journals.

IIT Guwahati deputed eight faculty members for teaching the first semester courses: two in Chemistry, two in Physics, one in ME, one in ECE and two in Maths. Three staff members were deputed to carry out the administrative work.

Procurements of hostel and office furniture, water Coolers, water filters. TVs, FAX machines, phones are made before the commencement of the session. Contracts for caterer for the hostel and the Institute canteen, security agency, cleaning and gardening agency, leasing of Internet Bandwidth were given.

First Orientation and Academic Registration

First batch of students joined IIT Patna on August 6, 2008.

Other Amenities for Students

Hostels were equipped with uninterrupted power and water supply. For recreation and entertainment of the students, the hostels had indoor games like Table Tennis and Carom, and a TV room. To keep the students fit and healthy, a well equipped gymnasium was also placed inside the hostel. Hostel wardens were put up in rented flats at a distance of approximately 300 meters away from the boys' hostel. Facility of one hour per day for five days in a week outdoor health service was arranged at the Institute through a private hospital. Contract was signed with two private hospitals for credit basis indoor service. These private hospitals at distance of approximately 2 km from the hostels. Ambulance services of the same hospitals were used in case of emergency. Students of IIT Patna were actively involved in extra-curricular and co-curricular activities. They have organized the first annual function of IIT Patna 'Annual Fest-09'. On the occasion, the students were given awards for their contributions in sports and other extracurricular activities.

Experts from IIT Roorkee were earlier consulted by the Bihar Government in selection of site. In December 2008, a letter was sent to the Chief Minister, Govt. of Bihar to expedite the speed of acquisition and handing over the land to IIT Patna. Plan of action for Phase I of construction at the campus of IIT Patna was prepared. It was advertised for architect for designing the campus master plan of IIT Patna in March 2009.

ORDER

Government has decided to set up 8 new Indian Institutes of Technology during the 11th Five Year Plan. In order to closely monitor as well as facilitate the work of establishment of these eight new IITs, it has been decided that the existing IITs will mentor the new IITs for first 2-3 years or till these are properly set up as per the details given below:-

2. The Directors of the existing IITs will take all necessary steps and suitably guide the new IITs with a view to ensure that the new IITs are able to bring in the required standards as are expected of an IIT. Till such time as the full time Directors are appointed for the new IITs, the Directors of the existing IITs will take all necessary decisions for the mentored IIT/IITs as the case may be. As it is also proposed to start academic sessions by taking suitable premises on lease rental basis for 2/3 years till the permanent campuses are built for the new IITs, the Directors of the existing IITs should make all the necessary arrangements. Preferably the temporary premises should be in the same place where the site has been selected for the location of the new IIT. In some cases, where a temporary premises is not just available or the site has not been finalized, the first batch of students of the new IIT could be housed in the existing IIT itself. It would be desirable to have the first batch of about 40 students each, following the reservation rule (including 27% OBC reservation), in 3 & 4 engineering branches.

3. All the mentoring IIT Directors are requested to send a monthly Report starting from May, 2008, indicating the requirement of funds or any other areas where action is required at Government of India level. All the new IITs will have to be registered as societies and will be brought in the ambit of The Institutes of Technology Act through an amendment of the Act. Detailed instructions regarding the registering of IIT Societies etc. are being separately issued.

1. The name of the Society is the Indian Institute of Technology Patna Society.
2. The registered office of the Society shall be situated at Navin Government Polytechnic Campus, Patliputra Colony, Patna = 800 013

3. The objects for which the Society is established are:

(i) to establish and to carry on the administration and management of the Indian Institute of Technology Patna hereinafter called 'Institute' of whose functions shall be :-

- b) to hold examinations and grant academic awards and distinctions or titles to persons;

- e) to establish, maintain and manage halls and hostels for the residence of students;
- f) to supervise and control the residence, to regulate the discipline of students of the Institute and to make arrangements for promoting their health; general welfare and cultural and corporate life;

- g) to provide for the maintenance of units of the national Cadet Corps for the students of the Institute;

- j) to institute and award fellowships, scholarships, prizes and medals in accordance with the rules and bye-laws :
- (ii) to make subject to the provisions of the Act, rules and bye-laws for the conduct of the affairs of the Society and to add to amend, vary or rescind them from time to time with the approval of the Central Government;

- (vii) to prepare and maintain proper accounts and other relevant records and to prepare an annual statement of accounts including the balance sheet of the Society in such form as may be prescribed by the Central Government in consultation with the Comptroller and Auditor-General of India;
- (viii) to forward annually to the Central Government the accounts of the Society as Certified by the Comptroller and Auditor-General of India or any other person appointed by him in this behalf together with the Audit Report thereon;
- (ix) to acquire and hold property provided that prior approval of the Central Government is obtained in the case of acquisition of immovable property;
- (x) to deal with any property belonging to or vested in the Society in such manner as the Society may deem fit for advancing its objects provided that prior approval of the Central Government is obtained for transfer of any immovable property.
- (xi) to constitute such committee or committees as it may deem fit;
- (xii) to delegate all or any of its powers to the Board of Governors of the Institute or to any of the Committee or committees constituted by it,

4. (i) The Institute shall be open to persons of either sex, and of whatever race, creed, caste or class, and no test or condition shall be imposed as to religious belief or profession in admitting or appointing members, students, teachers, workers or in any other connection whatsoever.

(ii) No benefaction shall be accepted by the Society which, in its opinion, involves conditions or obligations opposed to the spirit and object of this section.

5. All incomes/earnings from movable or immovable assets of the Society shall be solely utilised and applied towards the promotion of its aims and objects only as set forth in the Memorandum of Association and no portion thereof shall be paid or transferred directly or indirectly by way of dividends, bonus, profits or in any manner whatsoever, to the present or past members of the Society or to any person claiming through any one or more of the present or past members. No member of the Society shall have any personal claim on any movable or immovable assets of the Society or can make any profits whatsoever by virtue of his membership. Notwithstanding anything contained herein above, the Society shall not be debarred from making payment in good faith for remuneration to any member thereof or any other person in return for any service rendered to the Society or for travelling Allowance, halting or other similar charges.

6. The Central Government may at any time appoint one or more persons to review the work and progress of the Society or Institute and to hold enquiries into the affairs thereof and to report thereon, in such manner as the Central Government may stipulate. Upon receipt of any such report, the Central

Government may take such action and issue such directions as it may consider necessary in respect of any of the matters dealt with in the report regarding the Society or Institute, as the case may be and the Society shall be bound to comply with such directions.

7. If, on winding up or dissolution of the Society, there shall remain, after the satisfaction all its debts and liabilities, any assets and property, whatsoever, the same shall not be paid to or distributed among the members of the Society or any of them but shall be dealt with in such manner as the Central Government may determine.

- (i) 'Committees' means Committees of the Board.
- (j) 'Central Government' means the Government of India.



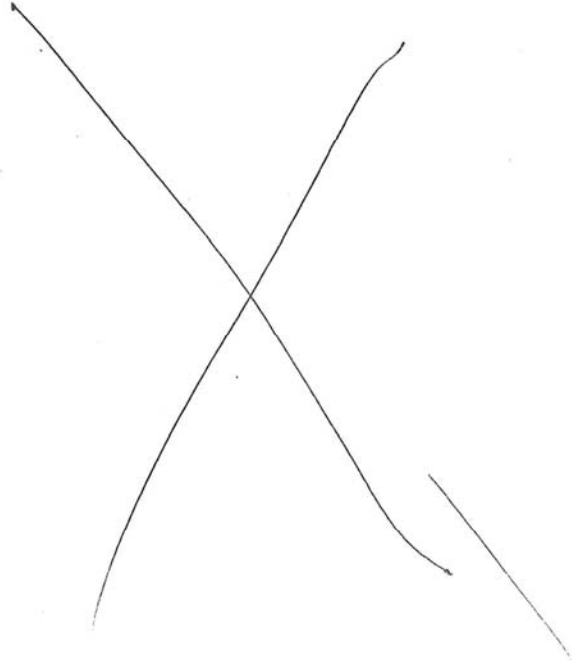

2. The expenditure on account of operation of the above posts would be met out of the Plan Budget of the respective Institute.

3. Further it has been decided that the teacher: student ratio in all the IITs would be 1:10. However, during the first three years of operation, each institute can hire/recruit faculty @ 30 per academic year for a period of three years, as per the table given above. The Faculty may be recruited by transfer on deputation / direct recruitment / contract basis. The number regular faculty including visiting or adjunct faculty or those appointed on contract or reemployment basis by the Institutes would be within the above mentioned sanctioned strength. Sanction of additional faculty positions would be linked to actual enrollment of students in respect of each of the IITs.
