INTRODUCTION

1. Sealed quotations are invited from eligible and reputed vendors as per eligibility criteria given in Annexure-I
2. The interested eligible bidders should download the NIQ from the official website of IIT Patna (i.e. iitp.ac.in in Tender/ NIQ Section) from 21.12.2022 to 26.12.2022.

3. Name of the WORK:

Renovation work of C-type quarters (4 nos) at IIT Patna.

The work will be done under supervision of Assistant Engineer (Civil, Residential zone), IIT Patna.

4. GENERAL GUIDELINES:

- i) The interested bidders may visit the site to have an exact idea regarding the Works to be done, before submission of bid.
- ii) The work to be completed within 20 days of receipt of work order as per delivery schedule.
- iii) Utmost importance should be given on the quality of work. It should be strictly as per direction of E/I.
- iv) Any item of substandard quality will be rejected out-right and the Executive Engineer Civil RZ.
- v) IIT Patna has the right to cancel the tender.
- vi) The quoted price should be valid for One year from the date work order. The agency will be informed when painting is required.

(c) Date and time of opening of quotation 26.12.2022 at 03.30 PM.

(d) Place of opening of quotation: In the Office of EE Civil RZ.

(e) Validity of quotations: **60 Days**.

6. a. The Quotation superscripted as “Renovation work of C-type quarters(4 nos) at IIT Patna. ” addressed to the EE civil RZ, IIT Patna, Kanpa Road, Admin Building, Bihta, Patna-801106, must reach not later than 3:00 p.m. on 26.12.2022.

b. After expiry of the scheduled date & time, no quotation will be accepted under any circumstances.

c. Rate should be quoted in the ‘PRICE BID FORMAT’ (Annexure-II and III & as per prescribed in the Quotation Document).

d. Prices shall be inclusive of all taxes, duties, GST, levies, transportation etc. as applicable. **If turnover is less than 40 lakhs an undertaking by the bidder to be given that no GST registration required.**

g. **Along with the quotation the bidders has to submit the following forms as well as credentials (self-attested) :-**

- I) **Experience Certificated as per Annexure-I**
- II) **Photo Copy of PAN.**
- III) **Price Bid Format (Annexure –II & III)**
- IV) **GST no (If required).**

7. TERMS OF PAYMENT:

IITP will deduct a sum at the rate of 5% of the gross amount from each running bill of the contractor as security deposit. Security deposit shall be refunded after six month of defects liability period. CPWD specification and condition shall prevail for other terms and condition.

8. In case of same price offered by two or more bidder, the bidders quoted L1(same) shall be called for Auction and offering the final price and then final L1 party shall be offered LOI.

Two *similar completed works costing not less than the amount equal to 60% of theestimated cost

OR

One *similar completed work costing not less than the amount equal to 80% of theestimated cost.

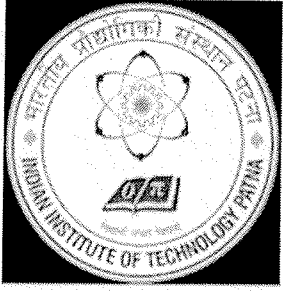
AND
