Registration shall be completely online. There is no need to physically visit the institute for registration/admission. Entry inside the campus may be allowed at a later stage. Please note that until verification of documents with original copies, admission shall remain purely provisional. The schedule of verification with originals shall be notified later.

The JoSAA Seat Acceptance fee paid by you shall be adjusted. The remaining amount has to be paid through SBI Collect on 24.11.2021.

Gen/OBC-NCL/EWS most economically backward students (whose family income is **below Rs One lakh per annum**) are eligible for full tuition fee waiver. Gen/OBC-NCL/EWS other economically backward students (whose family income is between **Rs. One lakh to Rs. Five lakh per annum**) are eligible for two-third tuition fee waiver. For availing of this concession/waiver, income certificate issued on or after 01 April 2021 by competent authority should be submitted latest by 31.12.2021. Please note that income certificate issued by Notary or Income Tax Return will NOT be accepted.

At present economically/most economically backward students are required to pay full fee. Upon receipt of income certificate by 31.12.2021, the paid fee shall be adjusted in subsequent semester(s).

Students are encouraged to open bank account in either SBI or Canara Bank (any branch).

Online registration begins from 24.11.2021 (Wednesday) The <u>orientation program</u> is scheduled on 26.11.2021 (Friday) Last date for online registration: 29.11.2021 (Monday) Online classes shall begin from 30.11.2021 (Tuesday) Academic calendar shall be available in website before 24/11/2021 on the following link
