Key Specifications for Bi Axial Servo Hydraulic Shake Table

1. Table:

- Shake table rated for 500 kg payload capacity at acceleration 1g.
- Table dimension: 1.0 meters x 1.0 meters
- Table should be designed for horizontal acceleration of 2g max
- Table must be designed for operating Peak velocity: 0.6m/s, Sustain velocity: 0.5m/s
- It should be designed for high stiffness with minimum value of 100kN/mm and operating frequencies up to 70Hz.
- The vendor should design the table with natural frequency at mode 1 more than 100Hz and report should be submitted along with the tender.
- Overturning moment should be 3T.m; torsional moment 1T.m
- Centre of gravity should be up to 1 meter from the surface of table with horizontal eccentricity less than 1m
- Table should be designed for Bi axial movement along X-axis and Y-axis.
- Table should be mounted on preloaded linear bearing with co-efficient friction of 0.05. Preferred make Hiwin, catalogue should be attached along with technical bid.
- Reaction frame should be grouted on seismic mass for vibration isolation
- Mounting holes provision -M12 STD thread on the table at 100mm pitch should be there for installing test components on the table
- Necessary grouting provision should be provided.

2. Servo hydraulic actuators for X and Y axis.

- Suitable load capacity (10KN or above) servo actuator of fatigue rated double acting, double ended equal area type
- Actuators should be provided with all required clamping devices to connect to the reaction table
- ± 100mm (total 200mm) displacement with built in digital stroke measurement with resolution of 1 micron or better and accuracy of ± 0.5% or better, preferred make Temposonic. The sensor should be standard one used in previous supply and reference needs to be provided along with technical document.
- High side load carrying capabilities with hydraulic cushions at both ends
- Should can achieve test frequencies up to 70Hz
- Suitable flow rated (minimum 40LPM) direct drive servo valves for contamination insensitivity operation, preferred make Bosch/Parker/Moog to conducting seismic study tests at frequencies up to 70 Hz

• Vendor should have to supply suitable hydraulic hoses of length at least 10 m from Tapping point to shake table distribution point, the distribution manifold must be supplied with min 10l hydraulic accumulator bank. The distribution manifold with start-stop valve should be supplied to connect existing HPU with the accumulator. All hydraulics and accessories should be compatible with existing HPU at IIT Patna.

9. General Requirements & Qualification Criteria:

- Firm should have ISO 9001:2015 Accreditation.
- Vendor should have track record of Single, Bi Axial and multi axes shake table systems supplied preferably to government institutions or research labs minimum 10 machines in period of last 10 years.
- List of Servo Hydraulic shake table installation is desirable. If the firms submit list of any other systems or system made by any other company, they will not be considered.
- Vendor shall submit the list of such supplies made preferably to government institutions and research labs with user name and contact details with year of installation and PO copies for references.
- In any circumstance, if the institution wants to verify the previous supply details, vendor should be in position to arrange for it without hesitation
- A factory tour/technical presentation at any point of time during technical evaluation should be arranged by the supplier upon prior notice of one week.
- Vendor should make the delivery of system within 16-20 weeks from the date of receipt of purchase order. Vendor should provide detailed activity/delivery chart for the supply of the system with bid.
- Vendor should have track record in this line of business (minimum period of 10 years) of supplying Structural Actuators, Shaketables and control systems.
- Firm should have Single Source Local Service Support Facility in North-East India and should submit address and contact details
- Vendors should offer for Pre-dispatch inspection free of charge at their premises for 2 users for 3 days and onsite training to 3 users for 3 days after installation at our lab

- 3. For Registration, Bidders are required to enroll on the e-Procurement module of the Central Public Procurement Portal (URL:http://eprocure.gov.in/eprocure/app) by clicking on the link *"Click here to Enroll". Enrollment on the CPP Portal is free of charge.

INSTRUCTIONS FOR ONLINE BID SUBMISSION

The bidders are required to submit soft copies of their bids electronically on the CPP Portal, using valid Digital Signature Certificates. The instructions given below are meant to assist the bidders in registering on the CPP Portal, prepare their bids in accordance with the requirements and submitting their bids online on the CPP Portal.

REGISTRATION

- 1) Bidders are required to enrol on the e-Procurement module of the Central Public Procurement Portal (URL: https://eprocure.gov.in/eprocure/app) by clicking on the link "Online bidder Enrolment" on the CPP Portal which is free of charge.
- 2) As part of the enrolment process, the bidders will be required to choose a unique username and assign a password for their accounts.
- 3) Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication from the CPP Portal.
- 4) Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate (Class III Certificates with signing key usage) issued by any Certifying Authority recognized by CCA India (e.g. Sify / nCode / eMudhra etc.), with their profile.
- 5) Only one valid DSC should be registered by a bidder. Please note that the bidders are responsible to ensure that they do not lend their DSC's to others which may lead to misuse.
- 6) Bidder then logs in to the site through the secured log-in by entering their user ID/ password and the password of the DSC / e-Token.

SEARCHING FOR TENDER DOCUMENTS

- 1) There are various search options built in the CPP Portal, to facilitate bidders to search active tenders by several parameters. These parameters could include Tender ID, Organization Name, Location, Date, Value, etc. There is also an option of advanced search for tenders, wherein the bidders may combine a number of search parameters such as Organization Name, Form of Contract, Location, Date, Other keywords etc. to search for a tender published on the CPP Portal.
- 2) Once the bidders have selected the tenders they are interested in, they may download the required documents / tender schedules. These tenders can be moved to the respective 'My Tenders' folder. This would enable the CPP Portal to intimate the bidders through SMS / e- mail in case there is any corrigendum issued to the tender document.
- 3) The bidder should make a note of the unique Tender ID assigned to each tender, in case they want to obtain any clarification / help from the Helpdesk.

PREPARATION OF BIDS

- 1) Bidder should take into account any corrigendum published on the tender document before submitting their bids.
- 2) Please go through the tender advertisement and the tender document carefully to understand the documents

required to be submitted as part of the bid. Please note the number of covers in which the bid documents have to be submitted, the number of documents - including the names and content of each of the document that need to be submitted. Any deviations from these may lead to rejection of the bid.

- 3) Bidder, in advance, should get ready the bid documents to be submitted as indicated in the tender document / schedule and generally, they can be in PDF / XLS / RAR / DWF/JPG formats. Bid documents may be scanned with 100 dpi with black and white option which helps in reducing size of the scanned document.
- 4) To avoid the time and effort required in uploading the same set of standard documents which are required to be submitted as a part of every bid, a provision of uploading such standard documents (e.g. PAN card copy, annual reports, auditor certificates etc.) has been provided to the bidders. Bidders can use "My Space" or ''Other Important Documents'' area available to them to upload such documents. These documents may be directly submitted from the "My Space" area while submitting a bid, and need not be uploaded again and again. This will lead to a reduction in the time required for bid submission process.

Note: My Documents space is only a repository given to the Bidders to ease the uploading process. If Bidder has uploaded his Documents in My Documents space, this does not automatically ensure these Documents being part of Technical Bid.

SUBMISSION OF BIDS

- 1) Bidder should log into the site well in advance for bid submission so that they can upload the bid in time i.e. on or before the bid submission time. Bidder will be responsible for any delay due to other issues.
- 2) The bidder has to digitally sign and upload the required bid documents one by one as indicated in the tender document.
- 3) Bidder has to select the payment option as "offline" to pay the tender fee/ EMD as applicable and enter details of the instrument.
- 4) Bidder should prepare the EMD as per the instructions specified in the tender document. The original should be posted/couriered/given in person to the concerned official, latest by the last date of bid submission or as specified in the tender documents. The details of the DD/any other accepted instrument, physically sent, should tally with the details available in the scanned copy and the data entered during bid submission time. Otherwise the uploaded bid will be rejected.
- 5) Bidders are requested to note that they should necessarily submit their financial bids in the format provided and no other format is acceptable. If the price bid has been given as a standard BoQ format with the tender document, then the same is to be downloaded and to be filled by all the bidders. Bidders are required to download the BoQ file, open it and complete the white coloured (unprotected) cells with their respective financial quotes and other details (such as name of the bidder). No other cells should be changed. Once the details have been completed, the bidder should save it and submit it online, without changing the filename. If the BoQ file is found to be modified by the bidder, the bid will be rejected.
- 6) The server time (which is displayed on the bidders' dashboard) will be considered as the standard time for referencing the deadlines for submission of the bids by the bidders, opening of bids etc. The bidders should follow this time during bid submission.
- 7) All the documents being submitted by the bidders would be encrypted using PKI encryption techniques to ensure the secrecy of the data. The data entered cannot be viewed by unauthorized persons until the time of bid opening. The confidentiality of the bids is maintained using the secured Socket Layer 128-bit encryption technology. Data storage encryption of sensitive fields is done. Any bid document that is uploaded to the server is subjected to symmetric encryption using a system generated symmetric key. Further this key is subjected to asymmetric encryption using buyers/bid opener's public keys. Overall, the uploaded tender documents become readable only after the tender opening by the authorized bid openers.
- 8)The uploaded tender documents become readable only after the tender opening by the authorized bid openers.

9)Upon the successful and timely submission of bids (i.e. after Clicking "Freeze Bid Submission" in the portal), the portal will give a successful bid submission message & a bid summary will be displayed with the bid no. and the date & time of submission of the bid with all other relevant details.

10)The bid summary has to be printed and kept as an acknowledgement of the submission of the bid. This acknowledgement may be used as an entry pass for any bid opening meetings.

GENERAL TERMS AND CONDITIONS

- 01. <u>Rates:</u> Rates quoted for indigenous items must be on F.O.R basis for IIT Patna, on <u>DOOR DELIVERY</u> Basis, with break up as per details given in BoQ.
- 02. <u>Validity</u> (Both Foreign & Indigenous): The validity period of the offer should be clearly specified. It should be at least for 120 days from the last date of submission of quotations.
- 03. <u>Warranty/Guarantee</u>: The material is quoted with a minimum onsite Warranty/Guarantee period of 03 years, after the date of delivery, installation and acceptance at final destination.
- 04. <u>EMD:</u> EMD should be submitted in the Institute's Account using i-Collect of SBI. The link is given below: (https://www.onlinesbi.com/sbicollect/icollecthome.htm?corpID=1968961)
- 05. <u>Delivery:</u> Unless otherwise stated delivery of goods shall be at IIT Patna and will have to be effected maximally within **04** (**Four**) **months** from the date of issue of the Purchase Order. All aspects of safe delivery shall be the exclusive responsibility of the vendor.
- 06. <u>PAN, GST Certificates & TDS:</u> Scanned copy of PAN along with PAN of partners/owners (if applicable) and GST Registration Certificate in Form REG-06 must be uploaded with technical bid. Appropriate GST deduction at source will be applicable.
- 07. <u>Dealership Certificate:</u> Dealership certificate (in case of authorised dealers) and standard Technical literature on the offered products must be uploaded with technical bid.
- 08. **Performance Guarantee:** 03% in the form of Bank Guarantee/ Fixed Deposit of the total order value needs to be submitted for such period as to cover two months beyond the warranty period for any order for equipment's of more than Rs.1 Lakh. 10. Ground for Rejection of Quotation:

- (i) The quotations are liable to be rejected if the foregoing conditions are not complied with. The quotation should be complete in all respects if a firm quotes NIL charges / consideration, the bid shall be treated as unresponsive and will not be considered. The quotations shall be rejected if the information, on the outer cover of the bid, is not provided in the format given in the table in Page 1.
- (ii) Either OEM or its sole representative is allowed to bid. In case both have bidded, the bid OEM will be valid.
- (iii) If at any time of tender, cartelization is found, the bidding firms would be liable for legal action as per Ant-Competitive Practices (CCI).

- 13. <u>Liquidated Damage:</u> If a firm accepts an order and fails to execute the order in part or in full, as per the terms and conditions stipulated in the Purchase Order, it will be open to the institute to recover the liquidated damages from the firm at the rate of 0.5% per week of the order value subject to a maximum of 10% of the order value. It will also be open to the institute alternatively, to arrange procurement of the required stores from any other source at the risk and expense of the defaulter firm/vendor, which accepted

the order but failed to execute the order according to the stipulated agreed upon. Defaulter vendor(s)/firm(s) are also liable for blacklisting.

- (c) If the vendor, in either of the above circumstances, does not take remedial steps within a period of 30 days after receipt of the default notice from IIT Patna (or takes longer period in-spite of what IIT Patna may authorize in writing), IIT may terminate the contract / purchase order in whole or in part. In addition to above, IIT Patna may at its discretion also take the following actions: IIT Patna may procure, upon such terms and in such manner, as it deems appropriate, goods similar to the undelivered items/products and the defaulting supplier shall be liable to compensate IIT Patna for any extra expenditure involved towards goods and services to complete the scope of procurement.

15. Applicable Law:

- 17. **Important:** The **Director** may accept or reject any or all the bids in part of in full without assigning any reason and doesn't bind himself to accept the lowest bid. The institute at its discretion may change the quantity / upgrade the criteria / drop any item, at any time before placing the Purchase Order.
- 18. **Force Majeure:** The Supplier shall not be liable for forfeiture of its performance security, liquidated damages or termination for default, if and to the extent that, it's delay in performance or other failure to perform its obligations under the Contract is the result of an event of Force Majeure.
 - (i) For purposes of this Clause, "Force Majeure" means an event beyond the control of the Supplier and not involving the Supplier's fault or negligence and not foreseeable. Such events may include, but are not limited to, acts of the Purchaser either in its sovereign or contractual capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.
 - (ii) If a Force Majeure situation arises, the Supplier shall promptly notify IIT Patna in writing of such conditions and the cause thereof. Unless otherwise directed by the Purchaser in writing, the Supplier shall continue to perform its obligations under the Contract as far as is reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the Force Majeure event.
- 19. The in general Printed conditions of supply of the firm, if any, will not be binding on the Institute.
- 20. The bidders can quote only items with minimum 20% domestic value additional/local content. Local content means the amount of value added in India which shall be the total value of the item procured (excluding net domestic indirect taxes) minus the value of imported content in the item (including all custom duties) as a proportion of the total value, in percent. The bidders are required to furnish a self-certificate regarding the items meeting local content requirement, mandatorily mentioning following:
 - a. Percentage of Local Content (exclusive of services such as transportation, insurance, installation, commissioning, training and after sales services support like AMC/CMC etc.)
 - b. Location(s) at which the local value addition is made
