- 3. Problems related to Bihar: identification and possible solutions Funding agencies and Industries.

Board's Observation during 38th meeting:

Having perused the presentations submitted by different departments and chairmen of 03 committees listed here, the Chairman BoG directed to convene a meeting with HoDs and Chairmen of committees at the earliest. Interested BoG members may also join the discussion.

Action taken:

Complied with. However lead will present in short the progress made so far.

Board's Observation during 39th meeting.:

1. Health Care/ Medical Services

The presentation was made by Dr. Mahesh H. Kolekar, Associate Professor.

Observations:

- a) In fast changing world Institute will be in position to take up the challenging problems.
- b) Narrowly focused programs may be converted into broadly focused programs to match with technology development.
- c) Nomenclature of programs should be generic as far as possible.
- d) To see the possibility of awarding the degree jointly by IIT Patna and AIIMS Patna, Once MoU is finalized on mutually agreed basis.
- e) To explore Joint appointment of faculty with the collaborating entity.

2. Smart city:

(Energy, Power, water, food - all connected areas)

Dr. Rajiv Misra made the presentation.

Observations:

- a) Planning should align with the Vision of IIT Patna.
- b) Time specific goals may be fixed for desired results.

- c) For four smart cities declared by Govt. of Bihar. IIT Patna is identified as Third Party for assuring quality of work.
- d) IIT Patna will also assist in integration of Large Volume of Data related to infrastructure, communication and services.

3. Problem related to Bihar:

- Dr. Preetam Kumar presented the report. Major points highlighted during the presentation are as under.
 - a) DIT, DST, DoE and Department of Tourism of Govt. of Bihar have been approached for possible collaboration and funding.
 - b) The principal secretary has desired to take the help of IIT Patna for establishing model Engineering Labs in three engineering colleges.
 - c) DST Govt. of Bihar has indicated to take help for faculty development programmes of engineering college faculties, at IIT Patna.
 - d) There is also a proposal for setting up Center of Excellence in all government polytechnics. MoU for Center of Excellence has been finalized and to be signed soon between DST and IIT Patna.
 - e) DIT and DST have been approached to setup a Research Park in IIT Patna campus.
 - f) The education department has decided to setup science labs in different schools and to conduct training of science teachers. MoU is going to be signed by IIT Patna to setup model science labs in the schools.

Observations:

a) Due to ongoing Covid-19 Pandemic, the industries witnessed a complete paradigm shift in work culture and the employees have been mostly allowed to work from their respective places. The Professionals, working from Patna and nearby areas may be encouraged to use the technology enabled space of Incubation Centre of IIT Patna on chargeable basis for their office working. This arrangement will be worth proving for motivating our students and to give them a feel of industry culture.

Item No.: BOG 2021.37.06

Title in brief:

To consider and approve the Bye-Laws of IIT Patna Global Alumni Association.

The Board approved the Bye-laws with following observations:

The Board was apprised of the recommendations of Finance Committee made in its 2021/30th meeting, held on 26th October 2021.

Important recommendations made by the Finance Committee were as under:

- i. As a part of fee revision, the hostel fee has been revised to Rs. 6000/- per semester in place of Rs. 4900/- and academic fee to Rs. 3000/- per semester in place of Rs. 2900/-. Above changes will be applicable from academic session 2022-23.
- ii. Relocation charges to the retiring employees of IIT Patna may be reimbursed as per Gol rules.
- iii. Report of the internal committee constituted by the BoG for examining the admissibility of relocation charges/TTA to the employees who join the institute from other Govt. Dept./Autonomous bodies/PSUs/Other Organisations, was accepted.

These recommendations will be effective from the prospective date.

- iv. An estimate of Rs. 107,80,000/- (One crore seven lac eighty thousand only) for providing network connectivity to upcoming buildings was accepted.
- v. For clearing/filling the backlog of faculty positions that are lying vacant especially in SC, ST, OBC and EWS categories, it was advised to comply with the instructions given by the MoE.
- vi. The proposal to augment the Medical Infrastructure (men and material) was accepted.
- vii. Empanelment of various hospitals of Patna to provide cashless medical services to the employees and their dependents was recommended.

The Board approved the recommendations made by the Finance Committee in its 2021/30th meeting.

Comments of MoE: May be considered.

Meeting of 28th Senate was held on 13th October, 2021. The Board was apprised of the recommendations made by Senate by the Associate Dean, Academic.

Important recommendations made by the Senate were as under:

- i. Best BTP, MTP and M.Sc project award are to continue by giving away the certificates. Source of funding for cash award is to be explored.
- ii. Minor programs structure of different departments was recommended.
- iii. Maximum numbers of Research Scholars with a faculty member will be 07 (seven). An upper cap of 12 (twelve) including external students (from other CFTIs/reputed institutions was recommended. Joint supervision will be counted half.

- iv. A cap of 100 (one hundred) students on the basis of CPI was recommended in elective courses. In special cases, the Chairman Senate can relax it based on the recommendation from Course Instructor.
- Award of posthumous degree to Late Biswajyoti Mukherjee, who succumbed to Covid-19 was recommended.
- vi. Similarity Index in PhD Thesis was recommended within the limits of 10% 15%.
- vii. In the matter of Automatic enhancement from JRF to SRF in Ph.D program, it was resolved to strictly follow the timeline prescribed in Ph.D ordinance. If there is a delay up to 02 months in holding the enhancement, then Doctoral committee can recommend enhancement from an earlier date (after 02 years of admission/timeline prescribed in ordinance). Beyond delay of 02 months, the enhancement shall be effective from the date of seminar only. Hostel facility will not be provided to Ph.D students beyond 05 years of studentship.
- viii. For students failing to meet CPI criteria for continuing in UG/PG program, it was recommended to have slow pace program until maximum duration prescribed for the program(s). However if a student secures CPI below 5.0 (for B.Tech and M.Sc.) or 6.0 (for M.Tech.) in 02 consecutive semesters even in slow pace mode, s/he shall have to leave the program. The department (s) will monitor and assign a mentor for such student(s). The hostel facility shall not be available beyond the normal duration of the program(s).
- ix. Satisfactory (S) grade during evaluation of pending lab courses may be avoided and the lab courses may be completed through online viva/quizzes etc. as far as possible.
- x. Joint Ph.D program in collaboration with IIT Guwahati was recommended. Such collaboration may be applicable in case of foreign collaboration too.
- xi. Proposal for providing institute Ph.D fellowship in international programs for December 2021 program was agreed in principle.
- xii. The new program 'M.Tech in Artificial Intelligence' was agreed in principle. The course structure has to be reviewed and to be re-circulated among the senators for final approval.
- xiii. The proposal to start 'Executive M.Tech.' program was agreed in principle.
- xiv. Report of fee review committee was accepted, to be made applicable from academic session 2022-23.

The Board approved the recommendations made by Senate in its 28th meeting.

Comments of MoE: May be noted.

Before 2018, at IIT Patna, appointments on non—faculty positions were being made on contract of 3/5 years, after which the employees were confirmed in their posts following due process, based on satisfactory performance. This condition of likely confirmation after the contract period is over was explicitly mentioned in respective vacancy advertisement. The principles of transparency and open and fair competition were never violated, since the applicants knew right from the advertisement stage (No. IITP/RECT./002/2016 dated 17.08.2016), like in case of probation- that confirmation will be done based on performance. In their offer letter too (Clause 01 of offer letter no. R/IITP/RECT./2017/133 dated 01.03.2017), condition of confirmation/regularization was mentioned. From 2018, the Institute shifted completely to probation based appointments.

In line with the condition of confirmation mentioned in advt. and offer of appointment, people taken on board were confirmed with the approval of Chairman BoG subject to satisfactory performance evaluated by committee as per BoG approved procedure. Such confirmations were also got ratified in subsequent meetings of the BoG.

While ratifying 02 such cases of confirmation in its meeting held on 10th October, 2020, the BoG directed to take legal opinion on the process adopted by the Institute before remaining similarly placed cases are taken up for confirmation. The legal opinion of the advocate was placed before the Board in its last meeting held on 13thFebruary 2021.

A view citing Hon'ble Supreme Court's decision in case of Secretary, State of Karnataka vs Uma Devi is attracted in this matter, was expressed by Professor Yogesh Singh, Member BoG, prior to finalizing confirmation cases.

Opinions of 02 senior advocates viz; Mr. Naresh Dixit, Senior Standing Counsel, Hon'ble High Court Patna and Mr. V.K Upadhyaya, Senior Advocate, Hon'ble High Court, Allahabad were perused by the Board.

The committee as under was constituted for examining the matter in totality.

Dr. Arijit Mondal was relieved from IIT Patna on a lien of 01 year w.e.f. 14th Dec. 2019, to join IIT Kharagpur as Assistant Professor, Grade I. The lien was subsequently extended for 01 more year. Prior to his relieving to join IIT Kharagpur, he was appointed as Associate Professor at IIT Patna w.e.f. 05th Dec. 2019 on probation. As there is no provision under rules to grant the lien to a probationer, the lien was granted to him on his confirmed post of Assistant Professor, Grade I.

Based on his request, he was permitted to re-join IIT Patna w.e.f. 2nd Aug. 2021 on his confirmed position of Assistant Professor, Grade – I.

Dr. Arijit Mondal vide letter dated 02.08.2021 has represented to permit his re-joining at IIT Patna as Associate Professor, since prior to his release for IIT Kharagpur, he was appointed as Associate Professor, at IIT Patna after clearing all formal steps related to his selection as Associate Professor.

As per rules, the lien to Dr.Arjit Mondal was granted on his confirmed post of Assistant Professor. In light of comments of the MoE, the request of Dr. Arijit Mondal to allow his re-joining as Associate Professor was not acceded to by the Board.

The Board decided as above.

Non-teaching employees of the Institute have represented to consider their cases for next auto-upgradation after completion of minimum residency period, in line with Govt. of India guidelines. This provision of auto-upgradation; for example in case of Deputy Registrars, is not the part of our RR & PP document, though implemented in many IITs. A need was therefore felt to review the RR & PP document of IIT Patna, approved by the BoG in its 28thmeeting, for addressing the ambiguities with regards to superseding Govt. of India guidelines and other issues as may surface during the review. A committee comprising following members was constituted by the Director to review the document.

The Institute Health Centre is presently being managed through outsourcing. The NSMCH (Netaji Subhas Medical College & Hospital) manages the Health Care Facilities of the Institute for which a handsome amount is being paid on monthly basis. The vision of Academic Unit is to create, support, and maintain sustainable multidisciplinary academic programs at IIT Patna in accordance with the NEP 2020. The action plan of the academic unit has been provided below.

Near-term (next one years)

- Starting interdisciplinary programs in line with NEP 2020.
 - Minor program across the disciplines will be started to offer students an interdisciplinary exposure that will lead to innovation.
 - Industry oriented academic programs: New academic programs will be kick-started in collaboration with industries to provide trained manpower for solving live problems in industries.
- Opening Academic programs for Self-Sustainability
 - Executive M-Tech and Ph.D. programs: Flexible academic programs will be developed for offering high quality courses for upskilling of working professionals.
 - E-learning services: New e-learning courses offering nanodegrees will be started to enhance outreach.
 - Skill-centric certificate programs: Existing infrastructure can be used for creating skill-centric courses for vocational training. IIT
 Patna faculty can align with local technical training organizations.
- Joint Ph.D. programs with national and international universities: New joint programs will be started to foster collaboration with acclaimed national and international universities.
- Intellectual Property Generation, transfer, and monetization
 - Industrial problems should be taken for research work having long and short term impact on requirement.

Mid-term (one year to five years)

- Transformation of IIT Patna to multidisciplinary HEI: In line with NEP 2020, an active effort will be taken to transform IIT Patna into a multidisciplinary HEI. For this, collaborations with industries for starting new centres will be initiated and academic programs revolving around such centres will be designed and implemented.
- In line with NEP 2020, Open Distance Learning (ODL), Lifelong learning programs, and Bridge courses for socially disadvantaged students will be started.
- Positive attempts in the direction of impacting local HEIs by beginning large scale FDPs and teachers' training programs will be made.
