#### **General Terms and Conditions:**

- 1. Warranty: 3 years from date of installation
- 2. It is preferable that the vendor should have sold and installed suitable numbers of similar machines in India, user details, performance certificates to be produced from the organizations supplied to.
- 3. Spares and consumables to be provided as per the need; preferably free for 3 years of operation.
- 4. User manual to be provided in both soft & hard copies.
- 5. All the quotation should be supported by literature
- 6. Date of manufacture should be after the date of order
- 7. Installation should be done free; installation details should be mentioned in the quotation

Installation site requirements should be mentioned in the quotation (such as, Power requirement, space layout for installing machine etc.)

# **TECHNICAL SPECIFICATIONS**

#### As a part of general features of the spray drier, it should have

- 1) Control panel should be separate from the operating unit.
- 2) Blower to located before the chamber, so that it does not handle powder laden air.
- 3) In built air compressor should be provided. No external compressed air/compressor should be required.
- 4) Chamber of bigger diameter of 200 mm or better.
- 5) Control panel and operating unit should be built in SS 304.

1) Water evaporation capacity : 1.0 lt/hr (or better) at Inlet temp.  $\sim 250$  °C / Outlet temp.

~80-90°C

2) Heater capacity : 3 KW or better

3) Feed pump : Peristaltic pump with variable flow rate

4) Air compressor : may be included

5) Spray nozzle : type: 2 Fluid nozzle

6) Air flow : Downward co-current

7) Power supply : typically 220 V, 50 Hz

## **SCOPE OF SUPPLY**

1) Air filter : The air filter to be mounted on the SS housing. It

should have an efficiency of 90% (or better), down to  $\sim$ 10 microns. The filter may be removed and

cleaned.

2) Air blower : Centrifugal blower in SS 304. The blower should

be located before the heater, so that it does not

handle any powder laden air, unlike the case where the blower is located after the dryer. The blower may be provided with a VFD for adjustment of the air flow rate.

3) Electrical air heater The heating element to be enclosed in a SS 304

housing. The element should be of nichrome or better. The heater should be insulated. The heater output to be controlled through a SSR by the output from the inlet temperature PID controller.

4) Drying chamber The drying chamber should be of Borosilicate glass /

SS 316, with easy clamp type fittings.

5) Cyclone separator The cyclone separator to be in Borosilicate glass/

SS 316. The cyclone to be equipped with a glass

collection bottle.

The peristaltic pump (a self priming pump) is expected to

deliver the sample liquid from a container through

the silicon tubing to the spray nozzle.

The pump to be provided with a variable speed controller for precise speed regulation. A digital indication of the speed of the pump to be provided.

This should be typically a two fluid nozzle. The

nozzle assembly should consist of an inner tube for the liquid sample leading to a small diameter jet. Compressed air to pass through an outer tube. The compressed air should atomise the liquid into a fine spray. The nozzle assembly should be in SS

316.

8) Air compressor The air compressor is a diaphragm type compressor,

> hence it should provide clean air without any danger of oil contamination. The compressor to be located within the stainless steel housing. An air regulator is to be provided for controlling air pressure. A pressure transmitter to provide the

digital display of the air pressure.

9) Control panel The control panel should be in SS 304. It should

house the controls. The following should be

provided:

i) Inlet air temperature controller (PID with SSR output).

ii) Outlet temperature indicator. (PID)

Mains connection indicator.

On/off switch and indication for blower. iv)

On/off switch and indication for pump v)

vi) On/off switch and indication for electrical air heater.

On/off switch and indication for air compressor.

viii) Pump speed control with indication (Digital)

ix) Compressed air pressure indication (Digital).

: A stainless steel cabinet to house all the mechanical

components

- 3. For Registration, Bidders are required to enroll on the e-Procurement module of the Central Public Procurement Portal (URL: http://eprocure.gov.in/eprocure/app) by clicking on the link \*"Click here to Enroll". Enrollment on the CPP Portal is free of charge.
- 4. Foreign Bidders have to refer "DSC details for foreign Bidders" for Digital Signature Certificate requirements which comes under Download Tab at http://eprocure.gov.in/eprocure/app?page=Standard Bidding Documents &service=page and the remaining part is same as above and below.
- 5. While submitting the tender, if any of the prescribed conditions are not fulfilled or are incomplete in any form, the tender is liable to be rejected. If any tenderer stipulate any condition of his own, such conditional tender is liable to be rejected.

## **INSTRUCTIONS FOR ONLINE BID SUBMISSION**

(Department User may attach this Document as an Annexure in their Tender Document which provides complete Instructions for on line Bid submission for Bidders)

The bidders are required to submit soft copies of their bids electronically on the CPP Portal, using valid Digital Signature Certificates. The instructions given below are meant to assist the bidders in registering on the CPP Portal, prepare their bids in accordance with the requirements and submitting their bids online on the CPP Portal.

More information useful for submitting online bids on the CPP Portal may be obtained at: https://eprocure.gov.in/eprocure/app.

#### REGISTRATION

- 1) Bidders are required to enroll on the e-Procurement module of the Central Public Procurement Portal (URL: https://eprocure.gov.in/eprocure/app) by clicking on the link "Online bidder Enrollment" on the CPP Portal which is free of charge.
- 2) As part of the enrolment process, the bidders will be required to choose a unique username and assign a password for their accounts.
- 3) Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication from the CPP Portal.
- 4) Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate (Class III Certificates with signing key usage) issued by any Certifying Authority recognized by CCA India (e.g. Sify / nCode / eMudhra etc.), with their profile.
- 5) Only one valid DSC should be registered by a bidder. Please note that the bidders are responsible to ensure that they do not lend their DSC's to others which may lead to misuse.
- 6) Bidder then logs in to the site through the secured log-in by entering their user ID/password and the password of the DSC / e-Token.

#### SEARCHING FOR TENDER DOCUMENTS

- 1) There are various search options built in the CPP Portal, to facilitate bidders to search active tenders by several parameters. These parameters could include Tender ID, Organization Name, Location, Date, Value, etc. There is also an option of advanced search for tenders, wherein the bidders may combine a number of search parameters such as Organization Name, Form of Contract, Location, Date, Other keywords etc. to search for a tender published on the CPP Portal.
- 2) Once the bidders have selected the tenders they are interested in, they may download the required documents / tender schedules. These tenders can be moved to the respective 'My Tenders' folder. This would enable the CPP Portal to intimate the bidders through SMS / e- mail in case there is any corrigendum issued to the tender document.
- 3) The bidder should make a note of the unique Tender ID assigned to each tender, in case they want to obtain any clarification / help from the Helpdesk.

#### PREPARATION OF BIDS

- 1) Bidder should take into account any corrigendum published on the tender document before submitting their bids.
- 2) Please go through the tender advertisement and the tender document carefully to understand the documents required to be submitted as part of the bid. Please note the number of covers in which the bid documents have to be submitted, the number of documents including the names and content of each of the document that need to be submitted. Any deviations from these may lead to rejection of the bid.
- 3) Bidder, in advance, should get ready the bid documents to be submitted as indicated in the tender document / schedule and generally, they can be in PDF / XLS / RAR / DWF/JPG formats. Bid documents may be scanned with 100 dpi with black and white option which helps in reducing size of the scanned document.
- 4) To avoid the time and effort required in uploading the same set of standard documents which are required to be submitted as a part of every bid, a provision of uploading such standard documents (e.g. PAN card copy, annual reports, auditor certificates etc.) has been provided to the bidders. Bidders can use "My Space" or ''Other Important Documents'' area available to them to upload such documents. These documents may be directly submitted from the "My Space" area while submitting a bid, and need not be uploaded again and again. This will lead to a reduction in the time required for bid submission process.

Note: My Documents space is only a repository given to the Bidders to ease the uploading process. If Bidder has uploaded his Documents in My Documents space, this does not automatically ensure these Documents being part of Technical Bid.

#### **SUBMISSION OF BIDS**

- 1) Bidder should log into the site well in advance for bid submission so that they can upload the bid in time i.e. on or before the bid submission time. Bidder will be responsible for any delay due to other issues.
- 2) The bidder has to digitally sign and upload the required bid documents one by one as indicated in the tender document.
- 3) Bidder has to select the payment option as "offline" to pay the tender fee/ EMD as applicable and enter details of the instrument.
- 4) Bidder should prepare the EMD as per the instructions specified in the tender document. The original should be posted/couriered/given in person to the concerned official, latest by the last date of bid submission or as specified in the tender documents. The details of the DD/any other accepted instrument, physically sent, should tally with the details available in the scanned copy and the data entered during bid submission time. Otherwise the uploaded bid will be rejected.
- 5) Bidders are requested to note that they should necessarily submit their financial bids in the format provided and no other format is acceptable. If the price bid has been given as a standard BoQ format with the tender document, then the same is to be downloaded and to be filled by all the bidders. Bidders are required to download the BoQ file, open it and complete the white coloured (unprotected) cells with their respective financial quotes and other details (such as name of the bidder). No other cells should be changed. Once the details have been completed, the bidder should save it and submit it online, without changing the filename. If the BoQ file is found to be modified by the bidder, the bid will be rejected.
- 6) The server time (which is displayed on the bidders' dashboard) will be considered as the standard time for referencing the deadlines for submission of the bids by the bidders, opening of bids etc. The bidders should follow this time during bid submission.

- 7) All the documents being submitted by the bidders would be encrypted using PKI encryption techniques to ensure the secrecy of the data. The data entered cannot be viewed by unauthorized persons until the time of bid opening. The confidentiality of the bids is maintained using the secured Socket Layer 128 bit encryption technology. Data storage encryption of sensitive fields is done. Any bid document that is uploaded to the server is subjected to symmetric encryption using a system generated symmetric key. Further this key is subjected to asymmetric encryption using buyers/bid opener's public keys. Overall, the uploaded tender documents become readable only after the tender opening by the authorized bid openers.
- 8) The uploaded tender documents become readable only after the tender opening by the authorized bid openers.
- 9) Upon the successful and timely submission of bids (i.e. after Clicking "Freeze Bid Submission" in the portal), the portal will give a successful bid submission message & a bid summary will be displayed with the bid no. and the date & time of submission of the bid with all other relevant details.
- 10) The bid summary has to be printed and kept as an acknowledgement of the submission of the bid. This acknowledgement may be used as an entry pass for any bid opening meetings.

#### ASSISTANCE TO BIDDERS

- 1) Any queries relating to the tender document and the terms and conditions contained therein should be addressed to the Tender Inviting Authority for a tender or the relevant contact person indicated in the tender.
- 2) Any queries relating to the process of online bid submission or queries relating to CPP Portal in general may be directed to the 24x7 CPP Portal Helpdesk.

#### **GENERAL TERMS AND CONDITIONS**

- 01. <u>Rates:</u> Rates quoted for indigenous items must be on F.O.R basis for IIT Patna, on <u>DOOR DELIVERY</u> Basis, with break up as per details given in BoQ.
- 02. *Validity* (Both Foreign & Indigenous): The validity period of the offer should be clearly specified. It should be at least for 120 days from the last date of submission of quotations.
- 03. <u>Warranty/Guarantee</u>: The material is quoted with a minimum onsite Warranty/Guarantee period of 03 years after the date of delivery, installation and acceptance at final destination.
- 04. <u>EMD:</u> EMD should be submitted in the Institute's Account using i-Collect of SBI. The details may be seen on following webpage (https://www.iitp.ac.in/images/pdf/snp/SBI%20I-Collect.pdf)
- 05. <u>Delivery:</u> Unless otherwise stated delivery of goods shall be at IIT Patna and will have to be effected maximally within **04 (four) weeks** from the date of issue of the Purchase Order. All aspects of safe delivery shall be the exclusive responsibility of the vendor.
- 06. <u>GST Certificates & TDS:</u> Scanned Copy of GST Certificate must be uploaded with technical bid. Appropriate GST deduction at source will be applicable.
- 07. <u>Dealership Certificate:</u> Dealership certificate (in case of authorised dealers) and standard Technical literature on the offered products must be uploaded with technical bid.
- 08. <u>Performance Guarantee:</u> 10% in the form of Bank Guarantee/ Fixed Deposit of the total order value needs to be submitted for such period as to cover two months beyond the warranty period for any order for equipments of more than Rs.1 Lakh. In case of non-submission of BG/FD, an equivalent amount will be retained while payment till the above mentioned duration.
- 09. <u>Late and delayed quotation:</u> Late and delayed quotations will not be considered. In case any unscheduled holiday occurs on prescribed closing/opening date, the next working day shall then automatically be the prescribed date of closing/opening of the quotation with no change in timing.
- 10. **Ground for Rejection of Quotation:** The quotations are liable to be rejected if the foregoing conditions are not complied with. The quotation should be complete in all respects if a firm quotes NIL charges / consideration, the bid shall be treated as unresponsive and will not be considered. The quotations shall be rejected if the information, on the outer cover of the bid, is not provided in the format given in the table in Page 1.
- 11. **Payment:** Payment will be made within 30 days from the date of successful delivery and acceptance of goods at IIT Patna/ successful installation in case of machinery, equipments or the likes, generally through RTGS / FUND TRANSFER. Following information must be clearly written in the uploaded bank details for RTGS / FUND TRANSFER: -
  - (a) Name of the Firm with complete postal address
  - (b) Name of the Bank with Branch where the Account exist
  - (c) IFSC CODE
  - (d) ACCOUNT No

- 12. <u>GST Concession/ Exemption:</u> IIT Patna being an academic institute is entitled for availing Custom Duty Exemptions in terms of Notification No. 45/2017-Central Tax (Rate) Dated 14.11.2017, Notification No. 47/2017-Integrated Tax (Rate) Dated 14.11.2017 and as amended from time to time. **Please state clearly that this certificate is required.**
- 13. Liquidated Damage: If a firm accepts an order and fails to execute the order in part or in full, as per the terms and conditions stipulated in the Purchase Order, it will be open to the institute to recover the liquidated damages from the firm at the rate of 0.5% per week of the order value subject to a maximum of 10% of the order value. It will also be open to the institute alternatively, to arrange procurement of the required stores from any other source at the risk and expense of the defaulter firm/vendor, which accepted the order but failed to execute the order according to the stipulated agreed upon. Defaulter vendor(s)/ firm(s) are also liable for blacklisting.
- 14. Termination for default: Default is said to have occurred
  - (a) If the supplier fails to deliver any or all of the goods/ items/ services within the time period(s) specified in the purchase order or any extension thereof granted by IIT Patna.
  - (b) If the supplier fails to perform any other obligation(s) under the contract
  - (c) If the vendor, in either of the above circumstances, does not take remedial steps within a period of 30 days after receipt of the default notice from IIT Patna (or takes longer period in-spite of what IIT Patna

may authorize in writing), IIT Patna may terminate the contract / purchase order in whole or in part. In addition to above, IIT Patna may at its discretion also take the following actions: IIT Patna may procure, upon such terms and in such manner, as it deems appropriate, goods similar to the undelivered items/products and the defaulting supplier shall be liable to compensate IIT Patna for any extra expenditure involved towards goods and services to complete the scope of work.

#### 15. Applicable Law:

- (a) The contract shall be governed by the laws and procedures established by Govt. of India, within the framework of applicable legislation and enactment made from time to time concerning such Commercial dealings / processing, as may be applicable upon IIT Patna.
- (b)All disputes are subject to exclusive jurisdiction of Competent Court and Forum in Patna, India only.
- (c) Any dispute arising out of this purchase shall be referred to the Registrar IIT Patna, and if either of the parties hereto is dissatisfied with the decision, the dispute shall be referred to the decision of an Arbitrator, who should be acceptable to both the parties, (to be appointed by the Director of the Institute). The decision of such Arbitrator shall be final and binding on both the parties.
- 16. The acceptance of the quotation will rest solely with the Registrar, IITP, who in the interest of the Institute is not bound to accept the lowest quotation and reserves the right to himself to reject or partially accept any or all of the quotations received without assigning any reason(s).
- 17. <u>Important:</u> The Director may accept or reject any or all the bids in part of in full without assigning any reason and doesn't bind himself to accept the lowest bid. The institute at its discretion may change the quantity / upgrade the criteria / drop any item, at any time before placing the Purchase Order.
- 18. <u>Force Majeure:</u> The Supplier shall not be liable for forfeiture of its performance security, liquidated damages or termination for default, if and to the extent that, it's delay in performance or other failure to perform its obligations under the Contract is the result of an event of Force Majeure.
  - (i) For purposes of this Clause, "Force Majeure" means an event beyond the control of the Supplier and not involving the Supplier's fault or negligence and not foreseeable. Such events may include, but are not limited to, acts of the Purchaser either in its sovereign or contractual capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.
  - (ii) If a Force Majeure situation arises, the Supplier shall promptly notify IIT Patna in writing of such conditions and the cause thereof. Unless otherwise directed by the Purchaser in writing, the Supplier shall continue to perform its obligations under the Contract as far as is reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the Force Majeure event.
- 19. The in general Printed conditions of supply of the firm, if any, will not be binding on the Institute.

#### ADDITIONAL TERMS FOR IMPORTED GOODS

Following terms besides the fore mentioned terms will be applicable in case of foreign purchases:

- 01. **Rates**: Quoted rates should be in FCA/FOB terms and charges to be stated in the break-up as given in BOQ.
- 02. **After Sales Service**: In case of imported items, foreign manufacturing firms should indicate facilities available for after sales service, detail address and contact number of their local representative in India without which their offers are liable to be ignored.

#### 03. **Delivery:**

- (a) Delivery of goods at IIT Patna, Bihta/Kolkata airport will have to be maximum within 12 (twelve) weeks from the date of issue of the Purchase Order.
- (b) Partial shipment/transportation will not be allowed.
- (c) Delivery at Kolkata Airport only: As we do not have clearing agent in any other Airport, delivery is to be made only at Kolkata.

#### 04. Payment:

(i) Payment by an irrevocable letter of Credit (90% against delivery and rest 10% after successful installation of the Equipment) at FOB/FCA value non-negotiable through any overseas branch of State

Bank of India with unrestricted provision. All bank charges inside India will be borne by IIT Patna and outside India will have to be borne by the supplier.

OR

(ii) 100% Payment Basis: 100% payment by TT Swift / DD against delivery and upon satisfactory installation will be made. In this case, on receipt of your Order Acknowledgement and document (i.e. AWB and MWB) through our freight & forwarder, payment will be made for total ordered value.

Note: Please note LC will not be opened unless and until Letter of Acknowledgement in original is received at IIT Patna, directly from the Principals (Even in case of firms having subsidiary office in India). The Indian agents are therefore advised to submit quotation after consulting with their respective Principals abroad.

#### (iii) Indian Agent Commission:

Payment of agency Commission against FOB/ FAS Contract- Entire 100% agency commission is generally paid after all other payments have been made to the supplier as per the terms of the contract. Indian agents of foreign suppliers are to receive their agency commission in Indian Currency only. GFR 2017 provisions shall be binding.

#### 05. Customs Duty:

The institute is exempted from payment of customs duty vide GOI notification no.51/96-customs, dated 23.07.96, with regn. no. tu/v/rg-cde (1081)/2012, dated 20.06.2018. [Customs duty exemption certificate will be made available by the institute in regard to quotes in foreign currency only not against quotes made by a firm in Indian currency, unless the concerned firm is a foreign holding company with `FDI' certificate issued by the ministry of finance, govt. of India].

- 06. **Agency Commission**: The percentage of ex-works value to be paid to Indian agent in equivalent Indian currency as agency commission as applicable will have to be clearly stated in the quotation wherever applicable.
- 07. **Country of Origin**: While Country of Origin Certificate will not be insisted upon, the same however will have to be stated in the Original Invoice for payment through LC.
