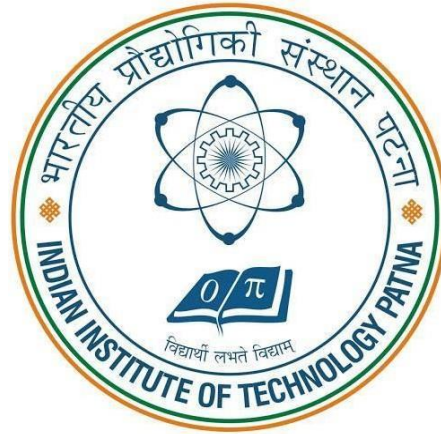

4. The interested Firms are not required to deposit any tender fees.

Earnest money Deposit (EMD) of Rs. 9,200/- (Rupees Nine Thousand Two Hundred only) to be deposited in the institute's account through SBI i collect and the receipt of submission is to be uploaded along other techno financial documents. 6. Bidders need not come at the time of Technical and financial bid opening at IIT Patna. They can view live bid opening after login on CPP e-Procurement Portal at their remote end. If bidder wants to join bid opening event at IIT Patna then they have to come with bid acknowledgement slip that generates after successfully submission of the online bid.

TECHNICAL BID

The Firms are required to upload copies of the following documents:-

- (a) Scanned copy of Receipt of the Earnest Money Deposit (EMD) / its exemption, if any.
- (b) Scanned copy of Registration Certificate with the Indian Pest Control Association (IPCA).
- (c) Scanned Copy of GST Number, PAN Card, PF registration, ESIC & EPF registration etc. whichever is applicable.
- (d) Scanned copies of work order and experience certificates as per the technical criteria of tender document and showing that the bidder has minimum of 05 years' experience in the field of captioned work.
- (e) Scanned copies of financial turnover documents (balance sheet and profit loss statement along with schedule) for the last five years ending as on 31st March, 2020, as mentioned in the tender document.
- (f) Scanned copies of documents which shows that the bidder is a sole proprietary concern, Registration number of Partnership firm or a company (registration certificate of firm/companies wherever applicable).
